Welcome to RoDevs. In this document:

- “Policy”, “document” refers to this Privacy Policy.
- “Us”, “we”, “website” refers to RoDevs and their website (<https://rodevs.com>).
- “You”, “your” refers to the end user.
- The names "Discord", "Roblox", "Google", "OpenAI", "Amazon Web Services", "Stripe" are used several times throughout this policy and are trademarks of Discord Inc, Roblox Corporation, Google LLC, OpenAI OpCo, LLC, Amazon Web Services, Inc., and Stripe, LLC, respectively.

The following policy explains what information RoDevs stores about you, how we process, secure and use your information, who we share what information with, and your rights regarding the collection of personal information.

RoDevs Website is based in the United Kingdom of Great Britain and Northern Ireland. However, our services are available internationally. We are committed to complying with all applicable data protection and privacy laws in every jurisdiction where we operate.

We reserve the right to update or modify this policy at any time. Any changes will be published on this page, and we will notify you of significant updates via Discord or other communication channels as appropriate. It is your responsibility to review these Terms periodically, as your continued use of our services constitutes your acceptance of any updates.

Personal Information We Collect

What is Personal Information?

We define personal information as any information that can be used to identify, locate, or contact an individual. This is generally (but not precisely) the globally accepted legal definition of personal information.

What personal information do we collect, and when do we collect it?

When you give personal information to us

We collect personal information when you give it to us. This includes (but not limited to):

- **Your Discord ID, username and profile picture.** When you first click the "Login" button, you will be forwarded to Discord.com, where you will be asked by Discord if you wish to give us access to this information. On clicking "Authorise", you acknowledge you have read this policy and it applies to your personal information.
- **Your Roblox ID.** When you verify via Roblox OAuth2, you are redirected to Roblox.com. Upon successful verification, we store your Roblox user ID (also known as OpenID). No other information from your Roblox account is stored.
- **Forms and Textual Input.** You may submit additional information through various forms on the RoDevs website and throughout the bot experience. The data collected depends on the purpose of the form (e.g., applications, posts, feedback) and may include usernames,

development portfolios, preferences, or other optional input. In this case we will make the purpose of the data clear to you, so that you know why it is being stored and how it might be published/shared.

- **Files you upload.** Any file you upload to the website will be stored by us until you remove it from your portfolio or invoke your right to erasure.

Automatically

We may automatically collect your Internet Protocol (IP) address, which is a unique identifier for your network. This will be collected automatically when you log into our service, complete the verification CAPTCHA or submit any User Generated Content.

Content you create or submit via the RoDevs platform (such as images, post content, or review comments) may be stored and displayed publicly. We strongly advise against including personal information in this content, as it becomes visible to all users and is outside our responsibility. Any user generated content you upload is shared at your own risk.

How We Use Your Information

- To provide and personalise our service, e.g. your name and profile picture at the top of the page
- To display your profile or portfolio to other users of the service
- To allow our staff to moderate any published material
- To improve our website, by anonymously using user's data to find ways to extend our service and fix issues
- To investigate potential breaches of our terms of service, our staff members reserve the right to access your data under confidentiality, unless we see it necessary to forward it to law enforcement, in which case you will be informed.
- To prevent "ban evading" (creating a new account after being banned) in our Discord server, by using your IP address and other data points (e.g. cookies and Roblox ID).
- To prevent abuse of our services (such as the reviews feature), by using your IP address.
- Communicate with you, e.g. we need to inform you of a data breach we will use personal details you gave us in order to contact you

Cookies and Tracking

Cookies are small files that are stored by your browser. We use them to remember who you are logged in as after you re-open your browser. We do this purely to identify you and improve your experience. We do not use cookies to track you between other websites and will not save any cookies to your browser until you log into our website, however our 3rd party service provider Google may use cookies to identify and track you, their own privacy policy applies on this matter.

Security and Protecting Your Data

We take reasonable steps to protect your personal information from loss, misuse and alteration, including by keeping your personal information in a secure database, using the very latest software and security protocols. However, data breaches are always possible no matter the security. In the unlikely event of a data breach, we will inform all users within 3 days of discovering the breach, likely via Discord.

Your Rights

You have the following rights, by the European Union's General Data Protection Regulations. If you wish to exercise any of these rights please contact us, see below.

1. **The right to be informed.** You have the right to know how your data is collected, used, shared and protected; hence this policy.
2. **The right of access.** You have the right to get a copy of all your data sent to you.
3. **The right to rectification.** You have the right to have inaccurate or incomplete personal information fixed or completed.
4. **The right to erasure.** You have the right to have all your personal information deleted. Please note we may retain certain information that is necessary for security, moderation, or legal compliance purposes, such as records of rule violations (e.g., modlogs), your Discord or Roblox user ID, or IP address used at the time of an infraction. This retention is based on our legitimate interest in maintaining the safety and integrity of our community and services, in accordance with Article 6(1)(f) of the UK GDPR.
5. **The right to restrict processing.** You have the right to limit how we process data after we store it.
6. **The right to data portability.** You have the right to get a copy of all your data sent elsewhere in a format easy to import into another IT system.
7. **The right to object.** You have the right to stop the processing of your personal information at any time.
8. **Rights in relation to automated decision making and profiling.** You have the right to not be profiled or automatically analysed if it is not necessary.

Children's Personal Information

We do not knowingly collect personal information of children under the age of 13, as we do not market for this age group. If you are aged under 13 or the parent of an under 13 and we have collected personal information about you/your child, please contact us as soon as possible (see below) so we can swiftly delete your data.
